1. DEACTIVATE No available leads or follow-up information available. This case can be reopened if additional information is received.
2. CLEARED BY ARREST Suspect is arrested or given a criminal summons to appear.
3. OPEN – WORKABLE Case is still under investigation and currently being worked on.
4. D/A NO FILE District Attorney's Office has reviewed the case and does not wish to proceed with the filing.
5. FILED WITH D/A Case has been filed with the DA's office and/or a warrant issued.
6. EXCEPTIONALLY CLEARED Crime did occur (except in the case of a runaway), but no prosecution will occur because: a. Handle Informally - for example, handled through civil court or mediation; b. Juvenile Handling – circumstances where you do not or cannot file charges on a juvenile suspect – for example the suspect is under 10 years of age; c. No Prosecution Desired - victim does not wish to prosecute; d. Refer to Other Agency – the case is forwarded to another agency for follow up – other law enforcement, human services, FBI, etc; e. Victim Refused to Cooperate - victim will not provide necessary assistance with investigation; f. Runaway – runaway or missing person has returned or been contacted; g. Death of Offender – Suspect or arrestee is deceased.
7. UNFOUNDED After the investigation, it was determined that no crime occurred.
